Each Unit consists of one share of common stock and one redeemable warrant. Each warrant entitles the holder thereof to purchase one-half (1/2) of one share of common stock. Each warrant will become exercisable on the later of the completion of an initial business combination, ("Initial Business Combination"), as described in more detail in the Issuer's prospectus filed with the SEC on December 14, 2018 (the "Prospectus"), or 12 months from the date of the Prospectus, and will expire five years after the completion of an Initial Business Combination, or earlier upon redemption. In accordance with Rule 13d-3(d) (1) regarding securities which represent a right to acquire an underlying security, each Unit has been reported herein as representing the beneficial ownership of one (1) share of common stock.

The Units are held by Boothbay Absolute Return Strategies LP, a Delaware limited partnership (the "Fund"), which is managed by Boothbay Fund Management, LLC, a Delaware limited liability company (the "Adviser"). The Adviser, in its capacity as the investment manager of the Fund, has the power to vote and the power to direct the disposition of all Units held by the Fund. Ari Glass is the Managing Member of the Adviser. Accordingly, for the purposes of Reg. Section 240.13d-3, the reporting persons herein may be deemed to beneficially own an aggregate of 489,000 Shares, or 5.59% of the 8,750,000 Shares that were issued and outstanding following the issuance made pursuant to the Prospectus.

This report shall not be deemed an admission that the Adviser, the Fund or any other person is the beneficial owner of the securities reported herein for purposes of Section 13 of the Securities Exchange Act of 1934, as amended, or for any other purpose.
